Ohukai Rd., in particular, but Keonekai needs them too, as does Welakahao. 8. The State has the Bike Plan Hawaii (2003) and the Statewide Pedestrian Master Plan (2013) for bicycle and pedestrian improvements. What will you do when elected to implement these plan? (short answer) *
